The current version of **Citrix XenApp and XenDesktop 7.15 Receiver for Web - Unified Experience** was tested for conformance with Section 508 of the Rehabilitation Act, specifically, the U.S. Access Board's Technical Requirements. This product was tested as of **July 11, 2017**, and is only valid for the version and date it was tested.

Assistive technology products used as part of testing included Freedom Scientific JAWS 18.0, Freedom Scientific MAGic 14.0, AI Squared ZoomText 11, Microsoft Windows accessibility features, and keyboard-only control.
