The Citrix StoreFront console allows administrators to manage a StoreFront configuration. StoreFront is an enterprise app store that aggregates applications and desktops from Citrix Virtual Apps and Desktops sites into a single store for users.

Testing was performed with this assistive technology on Windows Server 2022.
