


Registration Instructions Citrix Online Non-Disclosure Agreement

This guide provides instructions for registering an Online Non-Disclosure Agreement ("NDA"). A Citrix account is required for registration. Please follow steps 3 – 6 of this guide if you need to create a Citrix account.



1a. Go to https://www.citrix.com and click on the profile which will open up the SIGN IN box

1b. Select "My Account"



- 2a. If you already have a Citrix Account, enter your credentials and click "Sign in"
- 2b. If you need to create a Citrix Account, click "Create Citrix Account"


